He has also advised on various commercial matters and has been involved in international arbitrations conducted in Hong Kong.

Kaiser's recent notable cases include acting for the MTR Corporation Limited (led by Mr. Philip Boulding QC and Mr. Jat Sew-Tong SC) in **The Commission of Inquiry into the Construction Works at and near the Hung Hom Station Extension under the Shatin to Central Link Project**, the final report of which is expected to have a long-term impact on the construction industry.

In addition to his civil and commercial practice, Kaiser also has experience in matters concerning international law. He acted for the Asia Pacific Institute of International Law (led by Mr. Daniel Fung SC) in the submission of an *amicus curiae* brief on questions of jurisdiction and justiciability of issues in **The Republic of the Philippines v the People's Republic of China** (the South China Sea Arbitration). Prior to joining the Bar, he worked at the Office of The Prosecutor of the International Criminal Tribunal for the Former Yugoslavia in The Hague, where he was involved in the prosecution of war crimes.

Kaiser is a recipient of the Bar Scholarship (2014), the Charles Ching Memorial Scholarship (2015), and the Society of Construction Law Hong Kong Scholarship (2015).
